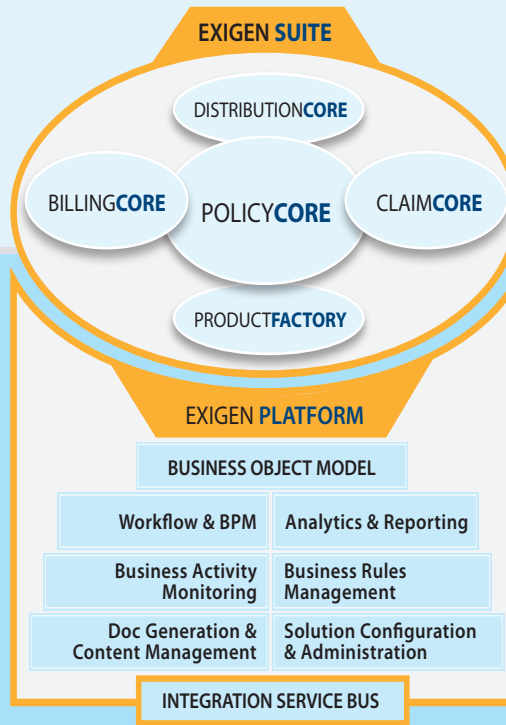
TECHNOLOGY
